ORDINANCE NUMBER 2017-29

AN ORDINANCE AMENDING ORDINANCE NO. 2017-22 WHICH AMENDED THE ORIGINAL APPROPRIATION ORDINANCE FOR 2017 TO CORRECT THE ACCOUNT NUMBER FOR THE FEMA GRANT REVENUE ACCOUNT, AND DECLARING IT AN EMERGENCY

WHEREAS, Ordinance No. 2017-22 amending the Original Appropriation Ordinance for 2017 to properly account for the FEMA Grant received by the Village of Carrollton fire Department stated an incorrect account number for the FEMA Grant Revenue Account as Account Number 216-0040-4-1480; and

WHEREAS, Council deems it necessary to correct the account number of the FEMA Grant Revenue Account.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1. The Enacting Clause of Ordinance No. 2017-22 passed on the 17th day of April, 2017 is hereby amended to read as follows:

"NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO that the Clerk-Treasurer of the Village of Carrollton be authorized to make the following additional appropriations and amendments to the appropriations for 2017 as follows:

Appropriation Amendments:

Fire Department FEMA Grant

216-0040-4-1418	(\$43,003.00)	FEMA Grant Revenue Account
216-2662-5-2500	\$43,003.00	FEMA Grant Capital Outlay Expense Account"

2. That the existing Enacting Clause of Ordinance No. 2017-22, passed on the 17th day of April, 2017 is hereby repealed.
3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio and the reason for the necessity being that there exists an imperative need to amend the current appropriations to cover necessary expenses approved by council and to comply with the laws of the State of Ohio, and to ensure FEMA Grant compliance, and the ordinance shall become effective at the earliest date allowed by law.
