

**VILLAGE OF CARROLLTON, OHIO
RESOLUTION NO. 2021-05**

**A RESOLUTION ADOPTING THE CARROLL COUNTY MULTI-JURISDICTIONAL
HAZARD MITIGATION PLAN, AND DECLARING IT AN EMERGENCY**

WHEREAS, natural, technological and man-made hazards can affect the Village of Carrollton;

WHEREAS, significant structural, historical and economic losses could result from an occurrence of a natural, technological or man-made hazard event;

WHEREAS, undertaking mitigation projects during pre-disaster periods could decrease the total losses the Village of Carrollton incurs as a result of said hazard occurrences;

AND WHEREAS, the Carrollton Village Council has a strong interest in reducing losses from future hazard occurrences;

WHEREAS, the hazard mitigation plan is a federal and state requirement to maintain eligibility for hazard mitigation funding, and, by that requirement, must be updated a minimum of every five years;

WHEREAS, a cooperative joint effort is a proven efficient way to plan for and reduce hazard susceptibility in all government jurisdictions in Carroll County, Ohio; and

WHEREAS, the Carrollton Village Council has partnered with the county to update the existing *Carroll County Multi-Jurisdictional Hazard Mitigation Plan* in an effort to further identify, define and characterize the hazards affecting the Village as well as to continue identifying and prioritizing projects that could lessen hazard vulnerability.

NOW, THEREFORE, BE IT RESOLVED the Carrollton Village Council does hereby adopt the updated *Carroll County Multi-Jurisdictional Hazard Mitigation Plan*.

This Resolution is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio to ensure an expedited adoption of the plan within the time deadlines set by the Federal and State Emergency Management Agencies, and shall become effective at the earliest date allowed by law.

ORDINANCE NUMBER 2021-06

**AN ORDINANCE ACCEPTING A RENEWAL OPTION UNDER THE KIMBLE RECYCLING
AND DISPOSAL, INC CONTRACT FOR REFUSE COLLECTION AND RECYCLING, AND
DECLARING IT AN EMERGENCY**

WHEREAS, the current contract with Kimble for refuse collection and recycling passed on January 11, 2016 by Ordinance No. 2016-03 provides in Section 13.1 thereof that the Village has an option to renew the contract for an additional one, three or five year period without the necessity to re-bid the contract; and

WHEREAS, the current contract with Kimble expires on January 31, 2021 and Council deems it necessary to opt to renew the contract to continue refuse collection and recycling services in the Village.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF
CARROLLTON, OHIO THAT:**

1. Pursuant to the option to renew the contract in Section 13.1 thereof, without the need to competitively bid the contract renewal, the contract with Kimble Recycling and Disposal, Inc. for refuse collection and recycling entered February 29, 2016 is hereby approved for renewal, as set forth in attached Exhibit A for a five year renewal term, commencing February 1, 2021.
2. Mark Wells, Village Administrator, is authorized to execute the contract renewal on behalf of the Village of Carrollton.
3. This Ordinance is declared to be an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio to ensure an expedited approval of the contract renewal and the uninterrupted provision of refuse collection and recycling services in the Village prior to expiration of the current contract, and shall become effective at the earliest date allowed by law.
