AN ORDINANCE ACCEPTING THE BID OF SUPERIOR PAVING AND MATERIALS, INC FOR  
THE 2021 STREET PAVING PROJECT, AND DECLARING IT AN EMERGENCY

WHEREAS, Council for the Village of Carrollton, Ohio has deemed it necessary to pave certain streets and/or alleys in the Village of Carrollton; and

WHEREAS, Council advertised for competitive bids for said paving project pursuant to the requirements of the Ohio Revised Code and deems it necessary to accept the bid of Superior Paving and Materials, Inc. of North Canton, Ohio, which bid met the minimum bid requirements and was the lowest and best bid.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF  
CARROLLTON, OHIO THAT:

1. The bid of Superior Paving and Materials, Inc. of North Canton, Ohio in an amount not to exceed \$153,086.00 is hereby accepted.
2. The Village Administrator, Mark Wells, is authorized to enter into a contract for said street paving project.
3. This Ordinance is declared an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents and students of the Village of Carrollton, Ohio to ensure the paving project is completed in an expedited manner prior to the start of the school year and to minimize the risk of property damage or personal injury or death as a result of dangerous conditions of the roads or alleys to be paved, and shall become effective at the earliest date allowed by law.

ORDINANCE NO. 2021-16

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF CARROLLTON, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Carrollton, Ohio;

WHEREAS, there have been numerous amendments to State law which need to be reflected in the Traffic, General Offenses and Fire Prevention Codes;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Carrollton, Ohio:

SECTION 1: The editing, arrangement and numbering or renumbering of the following ordinances and parts of ordinances are hereby approved as parts of the various component codes of the Codified Ordinances of Carrollton, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances, to-wit:

SECTION 2: That the following sections of the Traffic and General Offenses Codes, as amended, are hereby approved and adopted as amended or enacted so as to conform to enactments of the Ohio General Assembly:

- 331.43 Wearing Earplugs or Earphones Prohibited. (Amended)
- 335.09 Display of License Plates or Validation Stickers; Temporary License Placard. (Amended)
- 335.091 Operating Without Dealer or Manufacturer License Plates. (Added)

General Offenses Code

- 501.99 Penalties for Misdemeanors. (Amended)
- 505.04 Abandoning Animals. (Amended)
- 513.01 Drug Abuse Control Definitions. (Amended)
- 521.08 Littering and Deposit of Garbage, Rubbish, Junk, Etc. (Amended)
- 529.07 Open Container Prohibited. (Amended)
- 537.17 Reserved. (Previously "Criminal Child Enticement")

SECTION 3: A copy of such ordinances or parts of ordinances as edited, arranged and numbered or renumbered as parts of the Codified Ordinances is attached to this ordinance in the form of 2021 Replacement Pages to the Codified Ordinances.

SECTION 4: This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 5: This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of the Village, the reason for the necessity being that there exists an imperative need for the earliest publication and distribution of the 2021 Replacement Pages to the Codified Ordinances to the officials and residents of the Village, so as to facilitate administration, daily operation and avoid practical and legal entanglements.
