ORDINANCE NO. 2022-29

AN ORDINANCE AUTHORIZING THE VILLAGE OF CARROLLTON TO ACCEPT OWNERSHIP OF AND RESPONSIBILITY FOR ALL COSTS OF MAINTENANCE, REPAIR AND REPLACEMENT OF THE ODOT SR 332 SIDEWALK PROJECT, AND DECLARING IT AN EMERGENCY

WHEREAS, Council of the Village of Carrollton, previously approved the ODOT SR 332 Sidewalk Project for the construction of a new sidewalk, ADA facilities and other associated items on the northwest side of SR 332 (Scio Road) to connect the existing sidewalk facilities to the Carrollton High/Middle School.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1. The Village of Carrollton, Ohio is hereby authorized to take full responsibility for ownership of the connecting sidewalk once built pursuant to the ODOT SR 332 Sidewalk Project (PID No.: 115242) and to bear all costs of maintenance, repair and replacement for all aspects of the as-built sidewalk built within ODOT's right-of-way.
2. This Ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to meet the requirements of ODOT for issuance of the permit to commence the construction of the sidewalk project and the school safety benefits that will result to the community.
