

**VILLAGE OF CARROLLTON, OHIO
ORDINANCE NO. 2022-40**

AN ORDINANCE ADJUSTING THE LENGTH OF SERVICE INCREASE (LSI) FOR CERTAIN SALARIED EMPLOYEES OF THE VILLAGE, AND DECLARING IT AN EMERGENCY

WHEREAS, in Ordinance No. 2022-34, compensation rates were established for employees of the Village of Carrollton Service Departments;

WHEREAS, in Ordinance No 2022-35, compensation rates were established for employees of the Village of Carrollton Police Department; and

WHEREAS, Council deems it necessary to adjust the length of service increases (LSI) for certain salaried employees to give them an additional step increase to maintain pay equity and pay separation for supervisors.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1. Effective the beginning of the first pay period in January, 2023, the length of service increase (LSI) for the following salaried or formally salaried employees will be adjusted by one step of fifty cents (\$.50) per hour to maintain pay equity and pay separation for supervisors, as follows:

Geno Cook – Asst. Police Chief	\$32.00 /hour	\$32.50 /hour
Roy Ford (Wastewater Supt)	\$29.63 /hr.	\$30.13 /hr.
Derrick Kaltenbaugh (Water Supt.)	\$29.63 /hr.	\$30.13 /hr.
Tom Ferrell (former Street Supt.)	\$20.67 /hr.	\$21.17 /hr.

2. This Ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to ensure expedited approval of the adjustments for pay equity and pay separation for supervisors and the uninterrupted provision of services to the residents, and shall become effective at the earliest date allowed by law.

**AN ORDINANCE APPROVING THE FIRE PROTECTION SERVICES AGREEMENTS WITH
THE TOWNSHIPS OF ORANGE, HARRISON, LEE, UNION, WASHINGTON, CENTER AND
PERRY, AND DECLARING IT AN EMERGENCY**

WHEREAS, the fire protection services agreements with the various townships terminate on December 31, 2022;

WHEREAS, the Fire Chief has negotiated agreements with each of the townships for the cost of services based on past data on number of calls; and

WHEREAS, Council deems it necessary to enter into agreements with each of the townships.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1. The individual Fire Protection Services Agreements between the Village of Carrollton and the Townships of Orange, Harrison, Lee, Union, Washington, Center and Perry are hereby approved, as set forth in the Agreements attached hereto.
2. Shane Thomas, Fire Chief, and William J. Stoneman, Mayor, are authorized to sign the Fire Protection Services Agreements on behalf of the Village of Carrollton.
3. This Ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton and the various townships to ensure the expedited approval of the Fire Protection Services Agreements prior to the expiration of the current agreements on December 31, 2022, and shall become effective at the earliest date allowed by law.
