ORDINANCE NO. 2023-02

AN ORDINANCE AUTHORIZING THE VILLAGE OF CARROLLTON, OHIO TO SELL PERSONAL PROPERTY NOT NEEDED FOR PUBLIC USE, OBSOLETE OR UNFIT FOR USE BY INTERNET AUCTION PURSUANT TO ORC SECTION 721.15(D)

WHEREAS, Council for the Village of Carrollton, Ohio deems it necessary to authorize the sale of personal property which is not needed for public use, or is obsolete or unfit for the use for which it was acquired by internet auction pursuant to ORC Section 721.15(D).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1. It is hereby authorized that during the 2023 calendar year, personal property, regardless of its value, including but not limited to motor vehicles acquired for use by municipal officers and departments or road machinery, equipment, tools or supplies, which is not needed for public use or is obsolete or unfit for the use for which it was acquired, may be sold by internet auction pursuant to ORC Section 721.15(D).
2. The auction shall be conducted by the Village of Carrollton using the internet auction site GovDeals and the property shall be open for bidding for not less than ten (10) days, including Saturdays, Sundays and legal holidays, the terms of sale being for cash only with payment and pick-up/delivery due not more than thirty (30) days after the successful bid.
3. The Village of Carrollton, Ohio reserves the right to set minimum bid requirements for any individual item of property and reserves the right to reject all bids.
4. The Village of Carrollton shall publish notice of its intent to sell unneeded, obsolete or unfit municipal personal property by internet auction in the Free Press Standard twice, with the second notice begin published not less than ten days nor more than 20 days after the first notice of publication. The Village shall also publish notice of its intent to sell unneeded, obsolete or unfit municipal personal property on the Village of Carrollton website and on such additional internet sites as deemed reasonable for the type of property being sold to ensure that potential bidders receive actual knowledge of the intent to sell by internet auction.
5. The Village Administrator is hereby authorized to publish a description of the specific property to be sold during the calendar year in compliance with the publication requirements above.
6. The Clerk-Treasurer is directed to post a copy of this ordinance continually throughout the calendar year in a conspicuous place in the Village Administration Building and on the Village of Carrollton website.
7. This Ordinance shall become effective at the earliest date allowed by law.

**AN ORDINANCE AMENDING SUB-SECTION 521.08(a) OF THE CODIFIED ORDINANCES  
OF THE VILLAGE OF CARROLLTON, MODIFYING THE PROHIBITION AGAINST  
LITTERING AND DEPOSITING GARBAGE, RUBBISH, JUNK, ETC.**

WHEREAS, Council of the Village of Carrollton, Ohio deems it necessary to amend Section 521.08(a) of the Codified Ordinances to clarify that a property owner is prohibited from littering or depositing garbage, rubbish, junk, etc. on the owner's property.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1. Sub-Section 521.08(a) of the Codified Ordinances as enacted by Ordinance No. 1988-20, passed on the 11th day of July, 1988 is hereby amended to read as follows:

“521.08 LITTERING AND DEPOSIT OF GARBAGE, RUBBISH, JUNK, ETC.

(a) No person, regardless of intent, shall deposit litter, cause litter to be deposited or remain in place on any public or private property within the Village of Carrollton or on waters of the Municipality or of the State of Ohio. Any such litter is considered offensive and damaging to others including the general public creating a detrimental effect upon property values and being further detrimental to the health, safety and welfare of the residents of the Village.”

2. Existing Sub-Section 521.08(a) of the Codified Ordinances enacted by Ordinance No. 1988-20, passed on the 11<sup>th</sup> day of July, 1988 is hereby repealed.

3. This Ordinance shall become effective at the earliest date allowed by law.

AN ORDINANCE APPROVING THE APPLICATION FOR LOT SPLIT OF  
THE FIRST PRESBYTERIAN CHURCH OF CARROLLTON

Whereas, a request for the subdivision of certain property was made by The First Presbyterian Church of Carrollton, Ohio in the Village of Carrollton;

Whereas, the Council of the Village of Carrollton believes that such request is reasonable and that the subdivision of the property will not be detrimental to the general interest of the Village, and therefore that the subdivision should be approved;

Now, Therefore, Be It Ordained by the Council of the Village of Carrollton, Ohio that:

1. The lot split application of The First Presbyterian Church of Carrollton, Ohio is hereby approved, as depicted and described in Exhibit A of David Bodo & Associates, Inc., attached hereto.
2. This ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to ensure expedited approval of the lot split within the time deadlines of the lender so that a portion of the split lot will lose its tax exempt status and strengthen the tax base of the Village, and shall become effective at the earliest date allowed by law.
