# VILLAGE OF CARROLLTON, OHIO RESOLUTION NUMBER 2024-25

## A RESOLUTION AUTHORIZING SETTLEMENT OF A MORAL OBLIGATION FOR A SEWER LATERAL COLLAPSE

WHEREAS, owners of the property located at 505 South High Street in the Village of Carrollton have presented a claim to the Village of Carrollton alleging a sewer lateral collapse resulting in a sewer backup on the property;

WHEREAS, the Village investigated the sewer lateral collapse and concluded that additional aggregate placed above the buried lateral in an effort to temporarily support a storm drain to be replaced by a delayed engineered project involving a railroad right of way issue likely contributed to the sewer lateral collapse;

WHEREAS, the Village Solicitor has reviewed with the Village Administration the claim and has concluded that the action taken by the Village to temporarily support the storm drain was not legally enforceable against the Village because of sovereign immunity;

WHEREAS, the Village Solicitor has advised Council that it may recognize a moral obligation that would otherwise be legally unenforceable because of sovereign immunity or when the legally unenforceable obligation is binding upon the conscience of the municipality and the dictates of natural justice; and

WHERAS, Council desires to recognize the moral obligation.

NOW, THEREFORE, Be It Resolved by Council of the Village of Carrollton, Ohio

1. Payment of a moral obligation in an amount not to exceed \$854.71 to Susan J. Pallaye and David L. Pallaye, wife and husband, and Karen M. Ledford and Randall L. Ledford, wife and husband, is hereby authorized, conditioned upon the execution a Release of Claims by all four said property owners fully releasing the Village of Carrollton from all claims arising from the sewer lateral collapse and sewer backup, as set forth in attached Exhibit A.
