COUNCIL MINUTES

SEPTEMBER 23, 2024

7:00 O'CLOCK P.M.

Village council met in regular session on the above date and time in the council chambers of the Municipal Building with Mayor William Stoneman presiding over the meeting.

CALL TO ORDER: Mayor Stoneman called the meeting to order at 7:00 o'clock P.M and those present recited the Pledge of Allegiance.

PRAYER: Moment of silence was held for Minerva Mayor Tim Tarbert that had passed away on Sunday.

ROLL CALL: Everyone was present this evening.

MINUTES: White made a motion to approve the minutes from the Sept. 9, 2024 meeting and Locke seconded the motion. Roll call vote: Tangler, abstain; Yeager, abstain; Barto, yes; White, yes; Lambert, yes; Locke, yes. Vote being 4-2, motion carried.

SUPERVISORS REPORTS: Fire Chief Shane Thomas and Police Chief Tim Timberlake gave their monthly reports.

VISITORS: Barry Koenitzer lives at 411 Lincoln Avenue and his concern this evening was about a parking issue in front of his home. He said this same vehicle has sat there for a year and a half and he doesn't think it hardly ever moves. So he wanted to see what council could possibly change in the laws for extensive parking.

1. Conducted interview with applicant for the Sanitary Plant Senior Operator Position.
2. Met with Scott Green from "Greens and Things" and will begin replacement of nine trees in the downtown area as well as plantings on the upper and lower islands.

5. St. Rt. 332 sidewalk date of completion has been extended until December 5, 2024.

7. The Western Reserve Land Conservancy advised that the "Clean Ohio" grant application has been submitted for the purchase of the 13 acres of land to be used for the "Village Woods Park" located behind Mercy Health Center of Carroll County.

PAYMENT OF BILLS WITHOUT PRIOR CERTIFICATION REVISED CODE 5705.41: Barto made a motion to approve the bills without prior certification and Yeager seconded the motion. Roll call vote: Barto, yes; White, yes; Lambert, yes; Locke, yes; Tangler, yes; Yeager, yes. Vote being 6-0, motion carried.

COUNCIL: Barto reminded folks about the Walk to School Day on Oct. 2, 2024 at 8:00 o'clock a.m. Tangler ask about a dumpster someone complained to her about and how long they could stay in the Village.

PRESS: Nothing

PUBLIC: Next door neighbor Angie ask about painting lines on the street to stop people from parking and blocking her driveway. Village Administrator will have Street Superintendent Ben Palmer look into this matter. Chris Rutledge asked about the house on High Street and was told still waiting on a grant to tear all that up. Also, Chris spoke about the concern of crossing the street trying to get to work and how busy it is that you can't get across because of school traffic being non stop and wondered about crossing guards or changing the speed limit if any of that would help and how when the elementary moves out there it is going to be worse.
