AN ORDINANCE APPROVING THE INTER-AGENCY AGREEMENT BETWEEN THE COUNCIL OF THE VILLAGE OF CARROLLTON AND THE VILLAGE OF CARROLLTON STREET DEPARTMENT, AND DECLARING IT AN EMERGENCY

WHEREAS, the 2021 American Rescue Plan Act (ARPA) provided to the Village Coronavirus Local Fiscal Recovery Fund (CLFRF) monies which must be obligated and expended within time deadlines established by the US Department of Treasury;

WHEREAS, Council for the Village of Carrollton deems it necessary to allocate a portion of the awarded CLFRF funds to the 3rd Street Storm Sewer Improvement Project, which is an authorized use of ARPA funds under the Treasury Guidelines; and

WHEREAS, Council deems it necessary to enter an inter-agency agreement with the Village of Carrollton Street Department to obligate the CLFRF funds by the December 31, 2024 time deadline established by the Treasury Department

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL FOR THE VILLAGE OF CARROLLTON, OHIO THAT:

- 1. The Inter-Agency Agreement Between the Council of the Village of Carrollton, Ohio and the Village of Carrollton Street Department to obligate ARPA funds in the amount of \$179,750.00 to the 3rd Street Storm Sewer Improvements Project is hereby approved, as set forth in the Attached Exhibit.
- 2. Mark Wells, Village Administrator, and William J. Stoneman, Mayor/Council President, are authorized to execute the inter-agency agreement on behalf of Council, and Ben Palmer, Street Department Supervisor, is authorized to execute the inter-agency agreement on behalf of the Village of Carrollton Street Department.
- 3. Darla Tipton, Clerk-Treasurer, is directed to obligate the ARPA funds by transferring \$179,750.00 of the ARPA funds from Fund Account No. 217-2710-5-2500 to the 3rd Street Storm Sewer Fund Account No. 203-2323-5-2300.
- 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to ensure expedited approval of the inter-agency agreement and obligation of the ARPA funds within the time deadlines of December 31, 2024 established by the Treasury Department, and shall become effective at the earliest date allowed by law.

AN ORDINANCE ESTABLISHING THE EXPENSE ACCOUNT FOR THE 3RD STREET STORM SEWER IMPROVEMENTS PROJECT TO OBLIGATE ARPA FUNDS, AND DECLARIING AN EMERGENCY

WHEREAS, Council of the Village of Carrollton deems it necessary to allocate a portion of the Village's ARPA funds to the 3rd Street Storm Sewer Improvements Project, which is an authorized use of ARPA funds under the Department of Treasury Guidelines;

WHEREAS, ARPA funds must be obligated on or before December 31, 2024 under the time deadlines established by the Treasury Department; and

WHEREAS, an expense account for the 3rd Street Storm Sewer Improvements Project must be established to transfer and thus obligate the ARPA funds within the time deadline.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

- 1. There is hereby established an Expense Account for the 3rd Street Storm Sewer Improvements Project to separately account for expenditure of funds, as follows: Expense Account No. 203-2323-5-2300.
- 2. Darla Tipton, Clerk-Treasurer, is hereby authorized to establish said fund within the Village of Carrollton Fund Accounting System to separately account for such funds.
- 3. This Ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to ensure the expedited establishment of the 3rd Street Storm Sewer expense account to obligate the ARPA funds by the December 31, 2024 time deadline, and shall become effective at the earliest date allowed by law.

AN ORDINANCE ESTABLISHING AND APPOINTING TEMPORARY PART-TIME POSITIONS OF WASTEWATER PLANT OPERATOR AND ESTABLISHING THE PAY RATE THEREOF, AND DECLARING IT AN EMERGENCY

WHEREAS, upon recommendation of the Village Administrator, the Council for the Village of Carrollton, Ohio deems it necessary to establish and appoint new positions of Temporary Part-Time Wastewater Plant Operator within the Village of Carrollton Wastewater Department to have a Class III operator at the wastewater treatment plant until the plant is reclassified to a Class II plant and a Class II license is issued to Kevin Moore, as required by the Ohio EPA, and to establish the pay rate for said part-time positions requiring a Class III Waste Water License.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL FOR THE VILLAGE OF CARROLLTON, OHIO THAT:

1. The positions of Temporary Part-Time Wastewater Plant Operator are hereby established and appointed at the following pay rates in the Village of Carrollton, Ohio, as follows:

Wayne Ruckman- sixteen (16) hours per week at a pay rate of Fifty Dollars (\$50.00) per hour; and John Michael Heil- four (4) hours per week at a pay rate of Fifty Dollars (\$50.00) per hour. Said positions shall be under the supervision of the Village Administrator and shall require a Class III Waste Water License.

3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio to ensure continued operation of the wastewater department in compliance with the licensing requirements of the State of Ohio from December 20, 2024 until reclassification of the wastewater treatment plant to a Class II plant and issuance of a Class II Waste Water license is issued to Kevin Moore, as required by Ohio EPA, and shall become effective at the earliest date allowed by law.
